ALETTER FROM OUR EXECUTIVE DIRECTOR

Dear Sunrise Community,

We've all heard the saying that the only constant in life is change. Many of us living in Vermont love the changing seasons, with fall being a favorite for countless people due to its burst of color, milder days, and cooler evenings. Life at Sunrise is no different. We consistently experience changes in staff, programming, and how we conduct business. However, we also have staff and programs that have been with us for decades, anchoring us in our mission and keeping us rooted in our values as we continue to evolve.

A key focus for us is relationships—both building and maintaining them. We have a long history of cultivating strong relationships with families, agency partners, and the larger community. I am fortunate to frequently hear from community members about the wonderful job we do, how important our work is, and how families—and, as a result, our communities—are better off because of the great work Sunrise does. Often, this is work that goes "unseen," but the bottom line is that what we do matters—a lot.

At the start of this year, we set out to strengthen and expand our community connections. Over the past several years, we have successfully extended our reach by hosting Summer Jam, becoming the fiscal agent for the Warm the Children Program, embedding Social Capital programming into our services, and offering activities such as our felting workshops, which bring together different generations. In addition to our long-standing relationships, we have established more intentional partnerships with Turning Point and the Caring Dads Program, formalized through memorandums of understanding. We have also increased outreach and pop-up services with the Southwestern Vermont Supervisory Union and Greater Bennington Community Services and are growing our relationship with the Bennington Cultural Center. Project Alliance, a group of community leaders collaborating to build a healthy, safe, and thriving Bennington community, has expanded our opportunities to strengthen relationships. This has been great for everyone in our community and is a primary reason for our collective success.

We are also excited to announce that Sunrise will soon be home to the **Dolly Parton Imagination Library**, taking over the amazing work started by Nicole Campbell's Shires Kids. We are thrilled about this merger and happy that Nicole will continue as a volunteer.

I hope you enjoy reading some of our highlights from this year. Despite the ongoing challenges we face daily, we remain incredibly proud of the high-quality work we do and the growth we have achieved in recent years. Sunrise will continue to make positive changes in the lives of families! Our biggest goal for the coming year is to purchase a van for transporting high school students and for outreach services. FOCUS ON FAMILY

Bonnie and Zach were referred to the Family Advocacy Program (FAP) in July 2022, about a month after the birth of their first child, Isaiah. DCF was involved around concerns for the parents' ability to care for Isaiah, and a safety plan was developed. The family worked with FAP and Children's Integrated Services (CIS) sustained home visiting/nursing program, voluntarily and consistently. Their motivation to provide the best possible care to their new son was clear early on. They complied with the safety plan until they were notified there were no more restrictions around their contact. DCF exited the scene after a few months of involvement. Bonnie and Zach continued to work with services. Their FAP worker helped them understand child development and how to nurture their son's growth and safety through the Parents As Teachers (PAT) curriculum.

At time of referral, the family was living in a studio apartment (picture no bedrooms, but one room and a bathroom), with no working stove/oven. The space was overcrowded for anyone, but for a child who would soon need room to crawl, and explore, this was not even close to ideal. Dad needed to leave his job due to physical/medical issues. He applied for SSI, which took a good deal of time to obtain. Both parents would eventually earn disability payments as their sole income. The family was enrolled in FAP for one full year. They enrolled their son in the Early Care and Education (ECE) program at Sunrise with assistance from childcare subsidy. They continued working with the Sustained Nursing program, their son was assessed for and was found eligible for Early Intervention services, and they started attending periodic offerings at Sunrise (PAT group connections, Parent Education). As FAP services looked at closing with the family, CIS family support childcare opened for some continued support.

The family found a two-bedroom apartment, just around the corner from their old studio apartment. Their son, who has been their greatest motivation, now had room to crawl and then quickly walk.

In early February of 2024 the family welcomed another healthy beautiful boy, Makeino! They continue childcare for Isaiah and have decided to keep the new baby at home for his first year of life. There has been no further DCF involvement. They continue to work with service providers. They worked to correct a vision issue and ENT issues that impacted Isaiah's speech development. They are now enrolled in the Parents As Teachers home visiting program, both parents are involved with Families at the Center, they come to community picnics and CIS events, Making Meals and Memories, and they continue to work with their nurse home visitor.

Zach says that attending groups has been the greatest help for them. This is where they learned infant CPR, and gives them piece of mind, in case emergencies arise with their children.

Bonnie says that having someone to ask questions of is most helpful for her. Both of her boys were "choking" whenever they tried new foods. She learned that it's not uncommon for children to have this response when they are trying new textures in foods. Struggles still come up, as it does for any family with growing children, but they know that they have support whenever they need it.

Bonnie and Zach's world continues to revolve around their children, and each other. They practice what they learn and have become a significant part of the Sunrise family. ~Written by Lori Yunger





NEW RESOURCE COORDINATOR

The Resource Coordinator is a new position that was created to coordinate concrete supports Sunrise offers for families. Megan manages our pantry, which is stocked with healthy nonperishables, fresh produce from local farms, meats, dairy products, household items and cleaning products, as well as personal hygiene products. These offerings come from partnerships with the Vermont Foodbank. Stewarts Shops and ACT. You can find Megan in the kitchen cooking up meal kits for easy access for families. Sunrise receives a robust amount of in-kind donations from local businesses and community members. Megan coordinates the donations we receive and distributes to families who benefit from these generous contributions. In September, Sunrise partnered with area businesses for a diaper drive which was very successful. We received needed supplies of diapers, pull-ups and wipes for our community diaper bank that distributes over 650 packs of diapering products annually.

MORE VERMONT FAMILIES QUALIFY FOR CHILD CARE FINANCIAL ASSISTANCE

Beginning October 6, more Vermont families qualify for financial assistance to help pay for regulated child care, preschool, and afterschool care. The Child Care Financial Assistance Program (CCFAP) helps Vermont children access high quality care by covering some or all child care costs for eligible families. The program currently serves over 9,000 children across the state.

Families in the program pay a weekly family share. Family shares range from \$0 to \$425 per week based on family size and income. The State then pays the program the CCFAP state rate minus the weekly family share amount.

Under new CCFAP eligibility guidelines more Vermont families qualify for the program. The highest income eligibility level has increased to 575% of the federal poverty level (FPL), up from 400%. So, this means a family of four can earn up to \$179,400 annually. The FPL is a measure of income that determines a family's eligibility for programs. This change is the second and final income eligibility increase implemented as a result of Act 76. Income guidelines for the program increased in October, opening eligibility to more Vermont families.

To apply for CCFAP, families must meet the following eligibility requirements:

- · Age of children: 6 weeks to 13 years (19 years for those with special needs),
- Reason for care: Must have an approved reason for needing child care, like work or training
- Income guidelines: Must meet Vermont's income guidelines
- Residency: Must be a Vermont resident
- Asset limit: Have less than \$1 million in assets

DOLLY PARTON IMAGINATION LIBRARY

Sunrise Family Resource Center is happy to announce that it has officially taken over Dolly Parton's Imagination Library in Bennington County, a beloved initiative that has provided books to over 2,000 local children since its inception by Shire Kids in 2019. This transition marks an exciting new chapter in our collective commitment to fostering early childhood literacy and promoting a love of reading among young children in our community.

Dolly Parton's Imagination Library, founded by the country music icon in 1995, has been a transformative early literacy program, providing high-quality books to children from birth to age five. Under the stewardship of Shire Kids, the program reached thousands of families in Southern Vermont, delivering the joy of reading directly to their homes.

"We are immensely grateful to Shire Kids for making such a positive impact on our community by establishing the Imagination Library here," said Denise Main, Executive Director of Sunrise Family Resource Center. "We are excited to carry the torch forward and ensure that this incredible program continues to thrive, expanding access to even more children and families in Bennington County." Sunrise Family Resource Center plans to build on the foundation laid by Shire Kids, integrating the Imagination Library into its extensive array of family support services.

Each month, enrolled children will receive a carefully selected book tailored to their age group, nurturing their love for reading and supporting their early development. "We are thrilled that Sunrise Family Resource Center is taking over this important program," said Nicole Campbell, Executive Director of Shire Kids. "They have a strong commitment and history of supporting families, and we are confident that they will continue to inspire children and families through the power of books. I'm very excited for the Imagination Library to be in their capable hands." Nicole Campbell will continue as a volunteer, to handle the administration of the program each month.
